Dan Phillips has been a speech pathologist in the field of AAC for close to 25 years. He designed and built the Technology Resource Center of Marin in Marin County California that serves over 4,000 students with special needs. He continues to serve as the director of this organization that provides AAC and AT resources and supports to families throughout the Bay Area offering diagnostic consultations and evaluations as well as training on tools, apps and strategies to support the use of technology for communication, reading and writing for students from ages newborn to 22. He is an active member of CSHA, and currently serves as co:chair for the Operations Committee for the 2017 State Convention in Pasadena. Dan routinely lectures both locally, regionally, nationally and internationally. He offers a wide variety of trainings annually throughout Marin that address relevant topics regarding technology supports for education. He regularly lectures with university programs of Dominican and San Francisco State, local assistive technology programs in San Francisco and Sonoma, and SLP and parent organizations throughout the Bay Area. He travels extensively throughout California, speaking with SLP organizations in hospital, school and home health settings. Dan can be seen in January at the Future of Educational Technology Conference in Orlando, FL.
